Dear Parishioners,

You hold in your hands the 2014 Annual Parish Report which provides information about Sacred Heart Catholic Church and School for the Fiscal Year which began on July 1st, 2013 and ended on June 30, 2014. As parishioners it is important that you have access to this information concerning the vital statistics from Sacred Heart Parish over the last Fiscal Year.

I am happy to report, that thanks to your generosity we did post a surplus of \$96,246 for the last fiscal year. This surplus erases the operations deficit of (\$42,540) from Fiscal Year 2012 which came as a result of the installation of two new energy efficient hot water boilers in the Church building, and the operations deficit of (\$33,946) from Fiscal Year 2013 which came as a result of the unforeseen asbestos abatement in the School building. Both of these deficit causing projects came as a result of the Focus on Facilities Building Project though they were funded not from Campaign Funds, but from our operations budget. This means that over the three year period we had an operations surplus of \$19,740 or an average of \$6,587 for each year.

This surplus was not an accident, but came as a result of five things in particular. First, the parishioners of Sacred Heart continue to support our parish through the Adult Envelope and Plate Collections. Second, the Down With Asbestos Second Collection begun in May 2013 and held over 26 consecutive weeks ending at the beginning of November 2013 secured the funds necessary to meet the gap in the operating budget from the prior fiscal year caused by the Asbestos Abatement. Third, several households made an extra commitment over and above their regular giving from January 2014 through June 2014 to help bridge the gap in funding from the end of the redemption period for the Focus on Facilities Capital Campaign and the beginning of our follow up campaign. Bridge commitment donors symbolically built the bridge to the Sacred Heart: Our Home, Our Future, Our Mission Capital Campaign assuring that funds were available to pay both principal and interest payments so that current operations would not suffer. Fourth, the Sacred Heart Endowment begun in 1989 was again a source of strong support for our operations budget. Fifth, the administration of Sacred Heart Church and School was very conscious about spending decisions made last fiscal year to ensure that the extra efforts of parishioners made via the Down with Asbestos second collection and bridge commitments would be used as intended. All of these things are worthy of thanks, and so I express my gratitude to all of you who love and support Sacred Heart Church and School.

MISSION STATEMENT



The Newly Baptized July 1, 2013 - June 30, 2014

Faith and Baptism – from the Catechism of the Catholic Church (§ 1253-1255)

Baptism is the sacrament of faith. But faith needs the community of believers. It is only within the faith of the Church that each of the faithful can believe. The faith required for Baptism is not a perfect and mature faith, but a beginning that is called to develop. The catechumen or the godparent is asked: "What do you ask of God's Church?" The response is: "Faith!"

For all the baptized, children or adults, faith must grow after Baptism. For this reason the Church celebrates each year at the Easter Vigil the renewal of baptismal promises. Preparation for Baptism leads only to the threshold of new life. Baptism is the source of that new life in Christ from which the entire Christian life springs forth.

For the grace of Baptism to unfold, the parents' help is important. So too is the role of the godfather and godmother, who must be firm believers, able and ready to help the newly baptized - child or adult on the road of Christian life. Their task is a truly ecclesial function (officium). The whole ecclesial community bears some responsibility for the development and safeguarding of the grace given at Baptism.

First Penance & First Eucharist July 1, 2013 - June 30, 2014

Penance – from the Catechism of the Catholic Church – (§ 1422, 1427-1429)

"Those who approach the sacrament of Penance obtain pardon from God's mercy for the offense committed against him, and are, at the same time, reconciled with the Church which they have wounded by their sins and which by charity, by example, and by prayer labors for their conversion."

Jesus calls to conversion. This call is an essential part of the proclamation of the kingdom: "The time is fulfilled, and the kingdom of God is at hand; repent, and believe in the gospel." In the Church's preaching this call is addressed first to those who do not yet know Christ and his Gospel. Also, Baptism is the principal place for the first and fundamental conversion. It is by faith in the Gospel and by Baptism17 that one renounces evil and gains salvation, that is, the forgiveness of all sins and the gift of new life.

Christ's call to conversion continues to resound in the lives of Christians. This second conversion is an uninterrupted task for the whole Church who, "clasping sinners to her bosom, [is] at once holy and always in need of purification, [and] follows constantly the path of penance and renewal." This endeavor of conversion is not just a human work. It is the movement of a "contrite heart," drawn and moved by grace to respond to the merciful love of God who loved us first.

Peter's conversion after he had denied his master three times bears witness to this. Jesus' look of infinite mercy drew tears of repentance from Peter and, after the Lord's resurrection, a threefold affirmation of love for him. The second conversion also has a communitarian dimension, as is clear in the Lord's call to a whole Church: "Repent!"

St. Ambrose says of the two conversions that, in the Church, "there are water and tears: the water of Baptism and the tears of repentance."



The Sacrament of Holy Matrimony

Marriage - from the Catechism of the Catholic Church - (§1601-1602)

"The matrimonial covenant, by which a man and a woman establish between themselves a partnership of the whole of life, is by its nature ordered toward the good of the spouses and the procreation and education of offspring; this covenant between baptized persons has been raised by Christ the Lord to the dignity of a sacrament."

Sacred Scripture begins with the creation of man and woman in the image and likeness of God and concludes with a vision of "the wedding-feast of the Lamb." Scripture speaks throughout of marriage and its "mystery," its institution and the meaning God has given it, its origin and its end, its various realizations throughout the history of salvation, the difficulties arising from sin and its renewal "in the Lord" in the New Covenant of Christ and the Church.



The Sacrament of Confirmation

Confirmation – from the Catechism of the Catholic Church – (§ 1285, 1302-1304)

Baptism, the Eucharist, and the sacrament of Confirmation together constitute the "sacraments of Christian initiation," whose unity must be safeguarded. It must be explained to the faithful that the reception of the sacrament of Confirmation is necessary for the completion of baptismal grace. For "by the sacrament of Confirmation, [the baptized] are more perfectly bound to the Church and are enriched with a special strength of the Holy Spirit. Hence they are, as true witnesses of Christ, more strictly obliged to spread and defend the faith by word and deed."

It is evident from its celebration that the effect of the sacrament of Confirmation is the special outpouring of the Holy Spirit as once granted to the apostles on the day of Pentecost.

From this fact, Confirmation brings an increase and deepening of baptismal grace:

- it roots us more deeply in the divine filiation which makes us cry, "Abba! Father!";
- it unites us more firmly to Christ;
- it increases the gifts of the Holy Spirit in us;
- it renders our bond with the Church more perfect;

- it gives us a special strength of the Holy Spirit to spread and defend the faith by word and action as true witnesses of Christ, to confess the name of Christ boldly, and never to be ashamed of the Cross:

SACRED HEART CATHOLIC CHURCH & SCHOOL FINANCIAL REPORT JULY 1, 2013 – JUNE 30, 2014

The Finance Council and the Pastor present this Financial Report as an account of the stewardship to parishioners of Sacred Heart for the fiscal year July 1, 2013 – June 30, 2014. Total operations revenue was \$2,307,271, an increase of \$96,056 from the prior year. Total disbursements for the same period were \$2,211,025, a decrease of \$34,132 from the prior year. The net effect was an operating **surplus of \$96,246** for the year ended June 30, 2014 compared to a net **deficit of \$33,943** for the prior year. The surplus of FY 2014 erases the operational deficits of both FY 2012 and FY 2013 which combined was a net **deficit of \$76,486**. Looking over the three year period from July 1, 2011 – June 30, 2014 there was an operating **surplus of \$19,740**, or an average of \$6,587 per year. On the following pages you can review both the Funds Statement for FY 2014 as well as the Statement of Revenue and Disbursement for FY 2014 which provides a summary of the increase/decrease by category.

We ask that you be generous in your financial support and prayers so that we may continue our mission in the years ahead. Our parish continues to face the challenge of providing many different ministries and programs for our membership. Thank you for your continued support. We are most grateful.


Charitable Contributions

Our Sacred Heart Endowment Fund

The Endowment Fund was established in 1989 to ensure the legacy of Sacred Heart Parish. The Endowment Fund accepts gifts of cash or other assets and invests them for current and future needs of the parish. The original or principal gift remains untouched in the fund into perpetuity. A portion of what is earned on the investment of that gift is used to provide income year after year. During Fiscal Year 2014 the Endowment Fund used \$59,979 for parish operations and \$8,548 of interest earnings in fulfillment of its pledge toward the Focus on Facilities Capital Campaign and building project. In addition to smaller gifts during FY 2014 the Endowment Fund also received a generous gift of \$250,000 as partial payment of an estate gift to the fund. The total value of the Endowment Fund as of June 30, 2014 was \$1,345,025.

In accord with the policies governing the Endowment Fund, the Endowment Committee authorized a loan \$85,000 to the parish in May of 2013 in order that two additional unfinished classrooms could be added to Phase One of the Focus on Facilities building project. The parish is required to pay back the principal of these funds over time with an annual interest rate of 4.25%, which is the same as the commercial rate on our building project loan. In FY 2014 the parish paid interest of \$3,613 to the Endowment Fund for this loan.

Historically, over \$671,170 in cumulative interest earnings have been used to assist the parish with improvement projects and ministry for regular parish operations. In additional \$100,000 in cumulative interest earnings was used to support the Focus on Facilities Capital Campaign and building project. These projects help Sacred Heart to maintain and improve our facilities and programs. Most importantly, they give us all the opportunity to make Jesus Christ known and loved by furthering the mission of the Catholic Church in our own parish and in the world.

Sacred Heart Parish, now 103 years in existence, has been built by many generations of strong and faithful parishioners. Our Endowment Fund assists us to maintain and grow the parish while we are here. But, moreover, it will ensure Sacred Heart's presence in the future. Please remember the Church of the Sacred Heart Endowment Fund in your will. Your gift will help our ministry now and in future generations.

Building Project Timeline

2011.....In July the Building Committee led by Dave Detloff met with Architect Dan Gallagher to plot out the specific details for phase one of the Focus on Facilities Project.

In August five different General Contractors were interviewed. In September Langer Construction was chosen as the General Contractor.

In November Sacred Heart formally sought permission from the Archdiocese to begin construction on phase one.

2012.....In March formal permission was granted from the Archdiocese to enter into a contract with Langer Construction, and to seek the necessary financing for the building project. The architectural drawings were sent out for bid in March. A request for proposal was sent to four different lending institutions.

In April the Finance Council accepted the proposal of financing offered by Citizens Independent Bank of Robbinsdale in the amount of \$1.3 million. The Endowment Committee authorized an \$85,000 loan in order to add two extra classrooms onto the project. Sacred Heart formally entered into a Guaranteed Maximum Price contract with Langer Construction. Deacon James Ramsey agreed to serve as the official Owner's Representative to Langer Construction. Staging for the project began in late April, and the groundbreaking day occurred on May 6th, 2012.

On June 28th, 2012, Michael V. Mulcahy died after a six month battle with cancer. Michael Mulcahy was instrumental in planning and preparing for phase one of the Focus on Facilities Project.

In late October the elevator arrived, was assembled, and passed inspection paving the way for a substantial completion date of November 30, 2012 to be given.

On December 2nd, 2012, the Most Reverend Lee Piché, Auxiliary Bishop of the Archdiocese celebrated the 10:00am Mass followed by a blessing and dedication of the new Parish Commons and building addition. A plaque dedicated to the memory of Michael V. Mulcahy is unveiled by the Reverend Bryan J.B. Pedersen.

- 2013.....From January through February punch list items were completed. The final item of the project was completed in July, and landscaping was completed in August. A commemorative volume listing all the names of donors for the project remains in preparation.
- 2014...... Many parishioners made bridge committments over and above their regular parish operations contributions in order to provide a new source of revenue for principal and interest payments

for the building project debt. This six month commitment from January through June helped to bridge the gap in funding between the end of the redemption phase of the Focus on Facilities Capital Campaign, and the start of the follow-up Capital Campaign. With the end of the Archdiocesan moratorium on Parish Capital Campaigns, parish leadership interviewed four different consulting firms to assist with a follow-up Campaign. Lynch Development Associates was selected, and a strategic planning feasibility study was begun in June of 2014 to assess parishioners' views on a follow-up Capital Campaign.

Focus on Facilities Capital Campaign Results as of 6/30/2014.

The total amount pledged from all sources was \$1,813,979.

As of 6/30/2014 we have received 98.9% of what was originally pledged. We congratulate and thank all who have participated in the Focus on Facilities Capital Campaign and building project!

Building Project Results – Phase One

As of 6/30/2014 total project costs for phase one came to \$2,819,316. The costs labor and building materials, added change orders including the significant addition of the 41st Avenue Vestibule, contractor fees, architect fees, landscaping and incidentals. We were able to accomplish the following in phase one:

- ✓ A new gathering space that links the school, church and Activities Building
- \checkmark New accessible restrooms on the the main level of the church and Activities Building
- \checkmark New safe and secure school entrance
- ✓ New safe and secure entrances to the gathering space
- ✓ New centrally located elevator to access all areas of our campus
- ✓ Four new classrooms
- ✓ Creation of an attractive rain garden on the north side of the new addition

Project Loans - Phase One

As of 6/30/2014 our current bank loan balance with Citizens Independent Bank of Robbinsdale stands at \$950,123. The loan from the Endowment Fund stands at \$85,000. Both loans have an interest rate of 4.25%. With the hiring of LDA - Lynch Development Associates in May of 2014, a feasibility study began in June of 2014 to assess a follow-up capital campaign. The purpose of the follow-up campaign would be to address debt from phase one and assess parish opinion on other aspects of the November 2009 Campus Master Plan.
